Description

The CPC2017N is a miniature device with two independent, normally-open (1-Form-A) solid state relays in an 8-pin SOIC package that employs optically coupled MOSFET technology to provide 1500V_{rms} of input to output isolation.

Optically coupled outputs that use the patented OptoMOS architecture are controlled by a highly efficient infrared LED.

The CPC2017N uses IXYS Integrated Circuits' state of the art, double-molded, vertical construction packaging to produce one of the world's smallest relays. The CPC2017N offers substantial board space savings over the competitor's larger 8-pin SOIC relay.

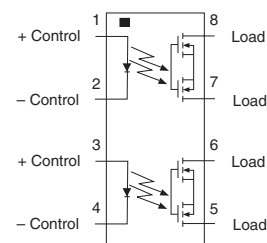

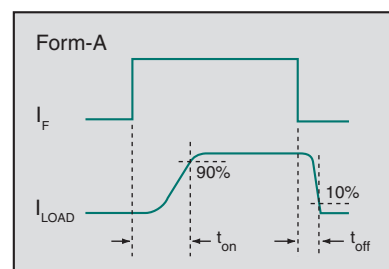

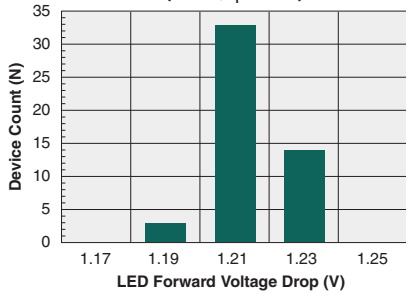

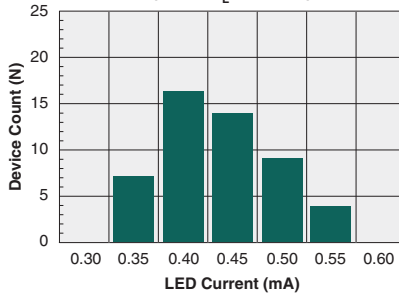

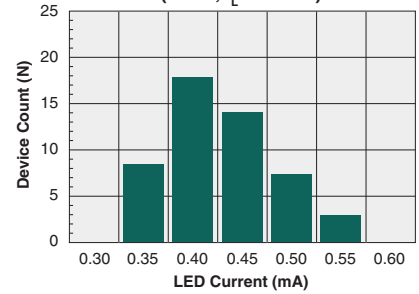
Typical LED Forward Voltage Drop
(N=50, $I_F=5mA$)



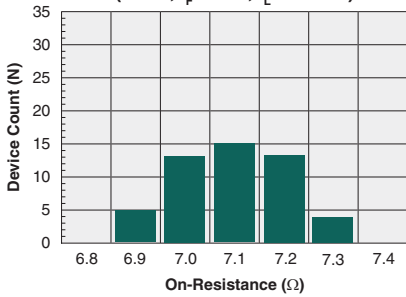
Typical I_F for Switch Operation
(N=50, $I_L=120mA$)



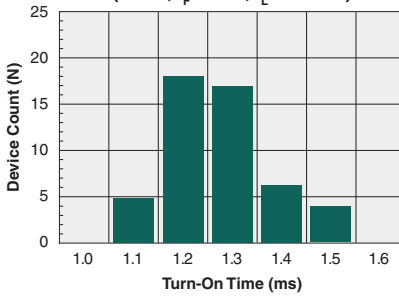
Typical I_F for Switch Dropout
(N=50, $I_L=120mA$)



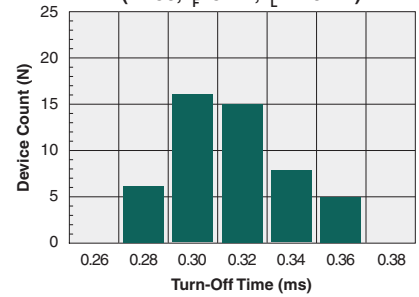
Typical On-Resistance Distribution
(N=50, $I_F=1mA$, $I_L=120mA$)



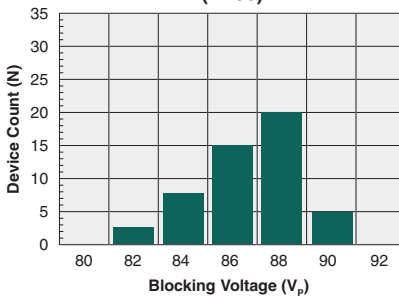
Typical Turn-On Time
(N=50, $I_F=5mA$, $I_L=120mA$)



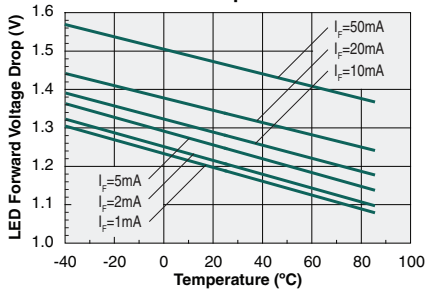
Typical Turn-Off Time
(N=50, $I_F=5mA$, $I_L=120mA$)



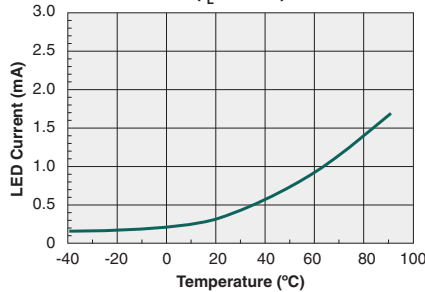
Typical Blocking Voltage Distribution
(N=50)



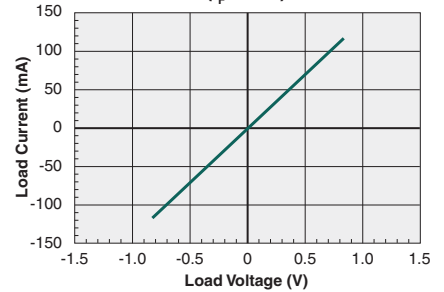
Typical LED Forward Voltage Drop vs. Temperature

($I_L=60mA$)



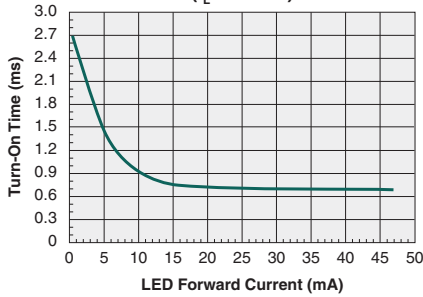
Typical Load Current vs. Load Voltage
($I_F=1mA$)



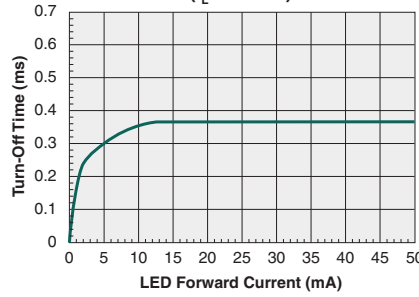

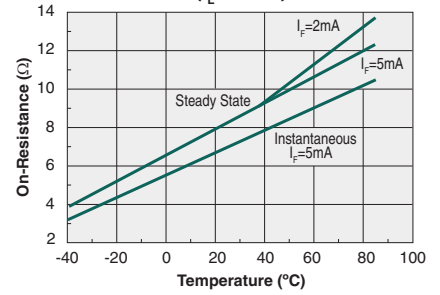
Typical Turn-On Time vs. LED Forward Current
($I_L=120\text{mA}$)



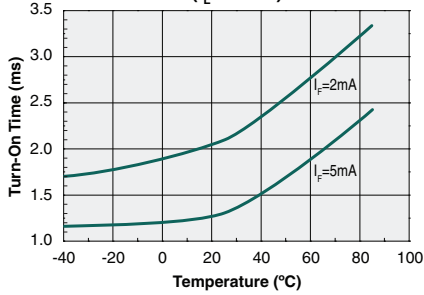
Typical Turn-Off Time vs. LED Forward Current
($I_L=120\text{mA}$)



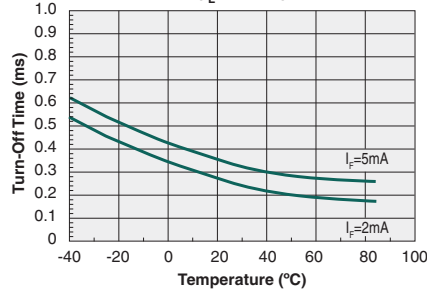
Typical On-Resistance vs. Temperature
($I_L=60\text{mA}$)



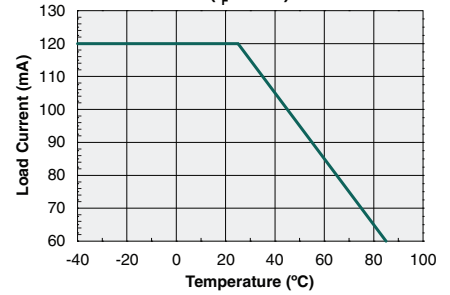
Typical Turn-On Time vs. Temperature
($I_L=50\text{mA}$)



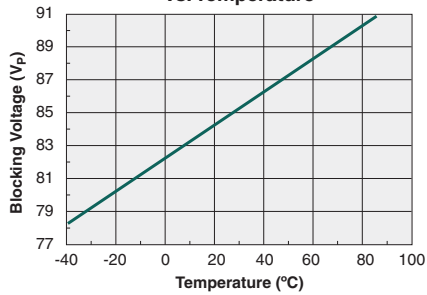
Typical Turn-Off Time vs. Temperature
($I_L=50\text{mA}$)



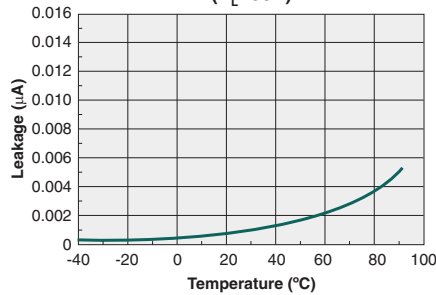
Maximum Load Current vs. Temperature
($I_F=2\text{mA}$)



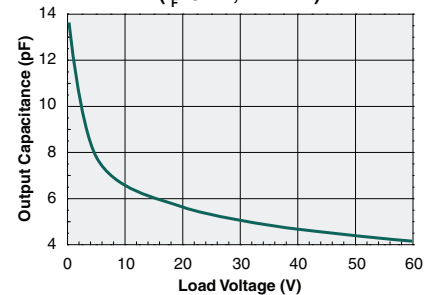
Typical Blocking Voltage vs. Temperature



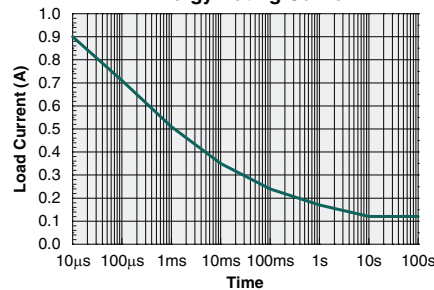
Typical Leakage vs. Temperature

Moisture Sensitivity

We test all of our products to the maximum conditions set forth in the standard, and guarantee proper operation of our devices when handled according to the limitations and information in that standard as well as to any limitations set forth in the information or standards referenced below.

Failure to adhere to the warnings or limitations as established by the listed specifications could result in reduced product performance, reduction of operable life, and/or reduction of overall reliability.

This product carries a **Moisture Sensitivity Level (MSL)** classification as shown below, and should be handled according to the requirements of the latest version of the joint industry standard **IPC/JEDEC J-STD-033**.

Soldering Profile

Provided in the table below is the **IPC/JEDEC J-STD-020** Classification Temperature (T_C) and the maximum dwell time the body temperature of these surface mount devices may be ($T_C - 5$)°C or greater. The Classification Temperature sets the Maximum Body Temperature allowed for these devices during reflow soldering processes.

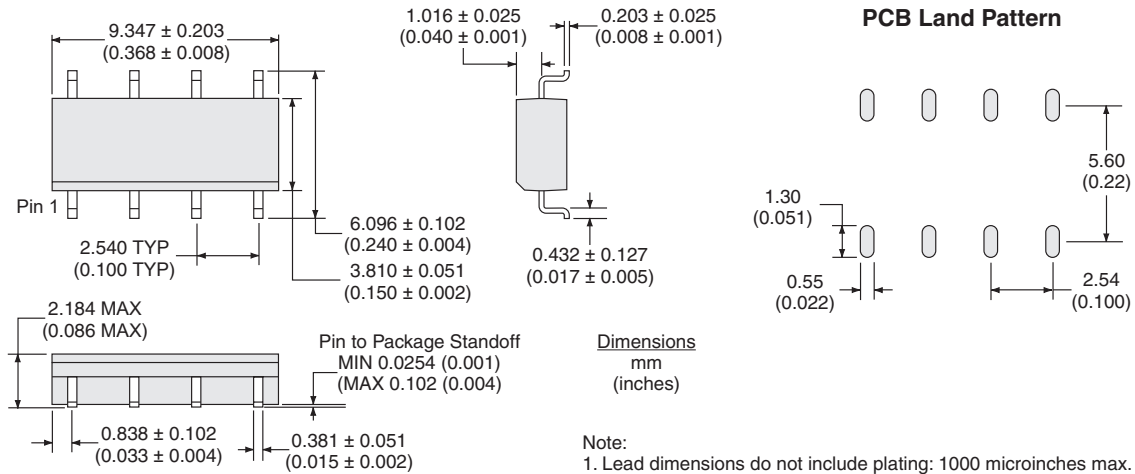
Board Wash

IXYS Integrated Circuits recommends the use of no-clean flux formulations. Board washing to reduce or remove flux residue following the solder reflow process is acceptable provided proper precautions are taken to prevent damage to the device. These precautions include but are not limited to: using a low pressure wash and providing a follow up bake cycle sufficient to remove any moisture trapped within the device due to the washing process. Due to the variability of the wash parameters used to clean the board, determination of the bake temperature and duration necessary to remove the moisture trapped within the package is the responsibility of the user (assembler). Cleaning or drying methods that employ ultrasonic energy may damage the device and should not be used. Additionally, the device must not be exposed to halide flux or solvents.

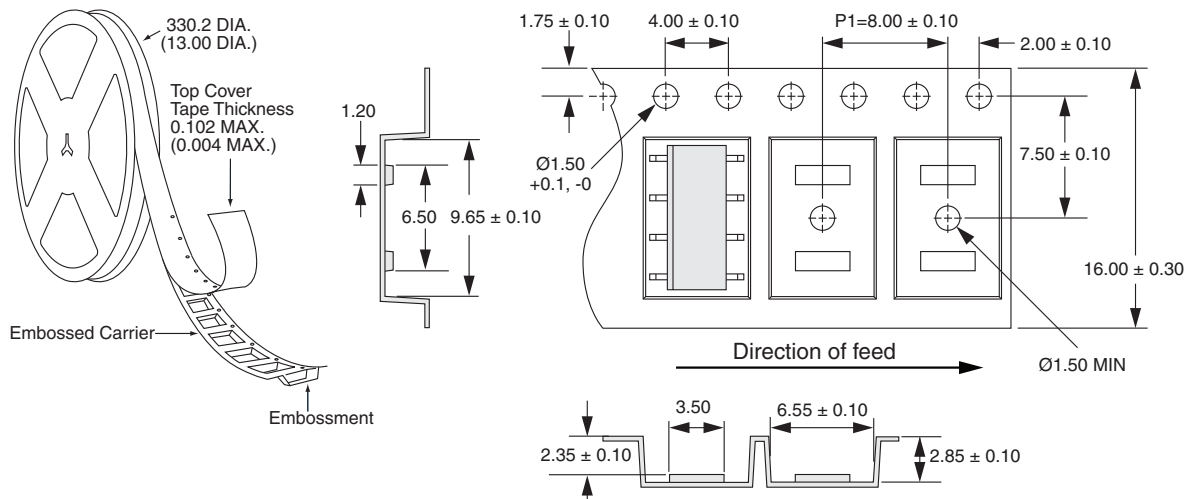
